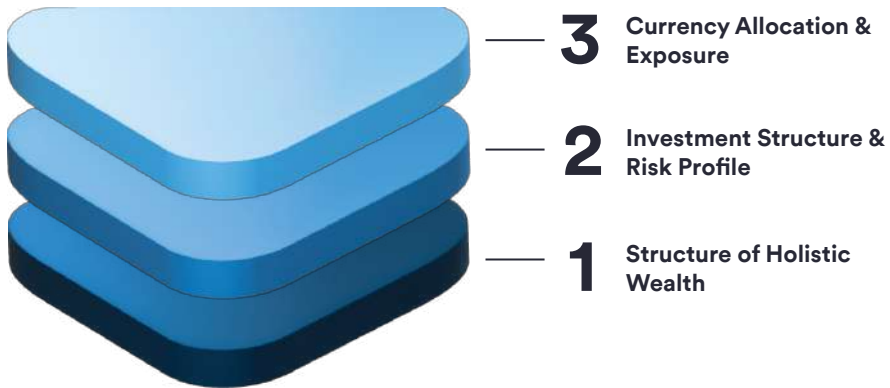


# The Three Dimensions of Holistic Wealth Advice

## 1. Structure of Holistic Wealth

### What belongs to your wealth – and in what context?

All assets and liabilities are recorded.

- **Bankable assets:** Bank account and custody account values
- **Non-bankable assets:** Pension funds (e.g. occupational pensions, pillar 3a), real estate, business equity, tangible assets (e.g. art, watches, classic cars)
- **Liabilities:** Mortgages, loans, other obligations

This overview highlights **which components shape the wealth, where they are tied up, and how they are embedded in the overall structure.**

## 2. Investment Structure & Risk Profile

### How is the wealth invested – across all elements?

All assets – including tied pension funds and illiquid assets – are transparently assigned to their respective asset classes:

- **Allocation by asset classes:** liquidity, bonds, equities, alternative investments
- Evaluation of **risk distribution and concentration risks** across the entire wealth
- **Liquidity:** Where is capital readily available, and where is it tied up long-term?

This results in an **objective view of the strategic allocation** – across the entire wealth.

## 3. Currency Allocation & Exposure

### What role do currencies play in holistic wealth?

Here too, all assets are taken into account – not just portfolio holdings, but also pension fund assets, foreign real estate, or business equity:

- **Determination of currency risk** at the total wealth level
- Analysis of hidden **foreign currency components**, e.g., in pension funds or business valuations
- Derivation of possible **hedging or diversification strategies**

This makes the currency dimension an integral part of the wealth advice – not a matter of chance.
